Leicestershire County Council – Insurance Position

- Pre-1964 No insurance purchased
- 1964 1969 Eagle Star
- 1969 1992 Municipal Mutual Insurance (23 Years In administration)
- 1993 1998 Independent Insurance (5 Years Wound up)
- MMI Scheme of Arrangement (SoA) Solvent run off of claims anticipated
- Mesothelioma 'trigger point' litigation Bolton BC v MMI & CU 2006 (2012 SC decision adverse to MMI)
- 2011 Uninsured Loss Fund established
- November 2012 MMI directors conclude SoA should be triggered

Leicestershire County Council – Insurance Position

- April 2013 Scheme administrator imposes a levy of 15% or £2.2M for LCC
- Deterioration of claims experience Meso / Abuse / NIHL
- Second levy of a further 10% or £1.5M for LCC
- June 2017 still showing a deficit of £1.4M
- December 2018 showing surplus of £7.2M
- Volatility / Long tail claims forecast out to 2050

Leicestershire County Council – Insurance Position

- Constant new developments:
- Extension to vicarious liability Woodlands / Armes / Barclays Bank / Morrisons
- Independent Inquiry into Child Sexual Abuse (IICSA)
- Limitation (Childhood Abuse) (Scotland) Act 2017
- Change to Ogden Discount Rate: -0.75% to +2.5%
- New types of claim: Idiopathic Pulmonary Fibrosis (IPF)
 - 'The second wave of asbestos claims?'
- New heads of claim: Mesothelioma future medical development costs.

The development of the law relating to child care claims

- Fast changing area of law affecting legal liability of the Authority in foster care and failure to remove claims
- We receive civil claims for alleged abuse dating from the 1950s to the present
- Earlier claims up to 31.07.64. uninsured
- In February we ran a seminar to update CFS, our internal legal services and neighbouring LA colleagues on the development of the law

The 3 most important recent cases in this area of law are:

Woodland v Essex CC

- A school contracted with a 3rd party to provide swimming lessons to pupils. During a lesson a 10 year old girl tragically suffered life changing brain injuries.
- Supreme Court held the school liable for the negligence of the independent contractor.

Armes v Nottinghamshire CC

- Female alleged abuse by foster carers who she was placed with as a child by NCC.
- The judgment of the Supreme Court held that NCC was vicariously liable for the tortious acts of its foster carers.

CN v Poole

- Claimants suffered from learning difficulties.
- They were harassed by neighbours in housing provided by the LA.
- In a favourable judgment to LAs the Court of Appeal held that no duty of care was owed to a child not the subject of a formal care order unless the LA had assumed responsibility for the child's welfare.

 α

- As a result of the decisions in Armes and Poole we have reviewed our current outstanding cases.
- Potential for an influx of foster care and failure to remove cases but, to date, this has not occurred. However, it is still early days.
- Whilst we can do nothing about cases arising from time past we can adapt to case law and mitigate LCCs exposure to claims for the future.

- The fostering sector is regulated by a number of acts and fostering regulations, as well as statutory guidance.
- These provide the legal and statutory framework for our organisation
- National Minimum Standards- best practice
- Independent scrutiny and professional challenge

- Team around the child- ensuring needs of child met
- Lower case loads good quality supervision
- High support emotional/ practical
- Training Officer deliver a full training programme (incl TSDs) building knowledge and confidence, strategies- reducing risk
- CAMHS consultation

Assessments and reviews

- Ensuring rigorous challenge leading to good quality assessments
- QA at each stage
- Role of Panel Advisor
- Foster panel Role of ADM
- Role of Reviewing Officer
- Annual Reviews
- Management oversight

- Training to prepare foster carers
- Role of LADO
- Role of Independent Support
- Role of Reviewing officer
