# Project Director's Update

Welcome to the March 2022 newsletter for the new prison at Glen Parva - HMP Fosse Way.

Progress continues to be made across the project as we have now structurally completed all 13 buildings. Following the Christmas break we have now managed to peak at approximately 800 operatives on site. The safety on site continues to be a primary focus for us as we have now achieved 1.2 million hours of work on site without a critical incident, no environmental incidents and only 3 minor injuries. Sadly, one of our colleagues, Guy Livingstone, passed away following a cardiac arrest on site, which was a very sad end to the year for the team here. Our heartfelt condolences go out to Guys' family.

We continue to try and keep all disruption to our neighbours and the surrounding area to an absolute minimum, which I hope you will agree we have succeeded in achieving to date.

All 13 buildings have now had their roof coverings installed which in turn has allowed the internal finishing works to get underway. Focus therefore, has now mainly turned to the fitout packages within the buildings which follows the mechanical and electrical 1st fix through to painting and resin flooring. The houseblocks are

progressing with the early ones entering the pre-commission stages and with fit out works starting at the last houseblocks.

The 5.2 metre security fencing replacement is underway which will provide a secure prison boundary and will also look better.

The external cladding and brickwork are now also completed at all buildings. The external works continue to change across the project as we continue the installation of the 60km of underground infrastructure services in and around all of the buildings. We are doing this while still maintaining our zero fossil fuel policy i.e. all machinery is running on hydrogenated vegetable oil.

Next, we will be working on having power turned on to the site and landscaping.







While we are doing well on our social value targets, which are detailed further on, we want to improve on these as much as we can, for example by increasing local apprenticeships, local spend, delivering the prison as sustainably as possible and endeavouring to continue on reducing our carbon footprint impact in line with Lendlease's policy of being net zero by 2025.

I was pleased to be able to join the naming panel in deliberating the future name for the prison and leaving a lasting legacy.

Finally, I would like to thank you all for your continued patience and support, and look forward to arranging a visit to the project. You can find the details later on in this newsletter on how to express an interest in this visit.

#### Operator announcement and new name

Some of you may have already read in the news about some significant developments for the new prison at Glen Parva. The prison will be known as HMP Fosse Way. The name was chosen after a community consultation opened in December last year, resulting in over 130 suggestions on what the prison should be called.

With some very well thought out and interesting suggestions made, it was no easy task to whittle the suggestions down for the panel to come to a recommended name. The panel, consisting of Leaders of Blaby District Council and Oadby & Wigston Council as well as Alberto Costa MP, recommended the name HMP Fosse Way to the Deputy Prime Minister who agreed it was a good choice as it reflects the history of the local area. The Fosse Way is a Roman road that runs through Leicestershire, and is reflected in the name of a number of local institutions. A huge thank you to everyone who sent in a suggestion!

Alberto Costa MP for South Leicestershire said:

"I was delighted to hear that so many local people have engaged with HM Prison and Probation Service's competition to find a name for the new Glen Parva prison. After careful consideration by the naming panel, it was suggested that HMP Fosse Way was the preferred choice and I am pleased that this has now been approved by the Deputy Prime Minister.

The community has already played a central part in the creation of the new prison, and so I very much look forward to continue working closely with the Ministry of Justice, and the new prison's operator to ensure that they remain proactive in maintaining these close ties with the local community and the people of South Leicestershire".

You may also have read that when the prison opens next year, that Serco has been named as the operator of HMP Fosse Way. Serco was awarded the contract to run HMP Fosse Way for 10 years after a robust competition. We look forward to welcoming the Serco team to the site soon, so they can begin working closely with everyone on site to ensure the prison is a success when it opens.

As of January 2022, we have created 301 new jobs and have provided over 2,700 days of work placements to people facing challenges to employment, this includes the delivery of pre employment training programmes on site as part of the Lendlease Training Academy.


