Comment from the Labour Group

### Item 5: Review of Homeless Support Services

The Labour group is committed to supporting the council objective of protecting services to the most vulnerable people in Leicestershire.

Whilst it's recognised that the support for accommodation for Homeless People in Leicestershire would be the responsibility of the District/Borough Councils.

The paper does highlight that the County Council is responsible to take appropriate steps to improve the health of people in Leicestershire. The paper also provides the shocking statistic that homeless people already have significantly lower levels of life expectancy of the local population. In light of this statistic, it's fair to conclude that people who are experiencing Homelessness are some of the most vulnerable people in society.

The Cabinet is being asked to consider the Homelessness services as though it's a single procured service, however it was confirmed verbally at Health Scrutiny in September that there are 3 smaller contracts with the In-reach support element, the support within the hostel, is just under 50% of the financial allocation.

Reviewing this as a single service the paper does not offer information on the impact closing each element of the service has on the homeless population. It also does not provide full financial information on each element of the service.

We would like the Cabinet to consider the 3 component parts of the service and identify the impact for each service area. It is a concern, that there no provision within the alternative approach which considers the specialist nature of Homeless support offered by the in-reach element within the Hostel settling.

Finally, we are concerned that the paper does not provide appropriate reassurance that absorbing the work of the specialist homeless provision into First Contact Plus or the Local Area Co-ordinator team is an appropriate route for homeless people. By providing an additional caseload that is complex into these teams, there has been no acknowledgement in the paper of the current service that would be displaced. # COMMENTS FROM MR. MAX HUNT CC (LOUGHBOROUGH NORTH WEST DIVISION)

Cycling represents the smoothest and most efficient way of making short journeys around Loughborough – and with all the accompanying health benefits. I therefore appreciate very much the work done by the department on these infrastructure plans and hope they are seen through to fruition.

I'm aware that it was important for the team to follow DfT guidance but I'm puzzled that the main focus was on the town centre and not the housing developments where journeys start. I am thinking particularly of those represented in the Charnwood Local Plan in Loughborough and Shepshed.

A simple 20mph limit within the town would be the best encouragement for walkers, cyclists and mobility scooters.
