Proposed motion

- a) That the 2023/24 provisional revenue and capital outturn be noted;
- b) That the prudential indicators for 2023/24 as shown in Appendix E to the report be noted;
- c) That the transfers to earmarked reserves, as set out in paragraphs 65 and 66 of the report, be approved.

5. RECYCLING AND HOUSEHOLD WASTE SITES - OUTCOME OF PUBLIC CONSULTATION AND PROPOSED SERVICE CHANGES (Pages 59 - 158)

Proposed motion

a) That the Somerby Recycling and Household Waste Site (RHWS) be closed with effect from October 2024;

- b) That the opening arrangements at the Recycling and Household Waste Sites at Bottesford, Market Harborough, Kibworth, and Shepshed be as follows with effect from October 2024:
 - i. Bottesford three days per week,
 - ii. Market Harborough three days per week,
 - iii. Kibworth four days per week,
 - iv. Shepshed two days per week;
- c) That the summer opening hours at all the Council's Recycling and Household Waste Sites be reduced with effect from April 2025, to be as follows:
 - i. from 9.00am to 5.00pm on Saturdays, Sundays, or Mondays;
 - ii. from 9.00am to 7.00pm on other days;
- d) That all the Council's Recycling and Household Waste Sites be closed on Christmas Eve with effect from December 2024;
- e) That subject to approval of a) above, the Somerby RHWS be considered for disposal.

Ibstock Library Petition Summary

A survey was undertaken around Ibstock community/commercial venues (for paper base survey) and on Ibstock Spotted Facebook page (www.facebook.com/share/p/rSNaRYGr9bwFRKrX/) to test the view of the community to assess the viability of making representation to the County Council to continue the Ibstock Community Library in some form in the future. There is a team of would-be trustees with a broad range of expertise ready to work with the County Council Library Services to resurrect Ibstock Community Library should the Cabinet Meeting decide not to permanently close Ibstock Community Library. The team comprises two parish councillors, a library services officer from Leicester Unitary Authority (witten.community Library team. Necessary funding streams (including Community Lottery) have been researched and are ready to be approached once a CIO is set up and policies have been written.

It is considered that this is an overwhelming call to retain a library resource in Ibstock, which is backed by a team with the skill, determination and expertise to successfully address previous cash flow shortfalls.

The survey had a total of 158 responses, 29 on Ibstock Spotted and 129 from community/commercial venues. This was supported by 81 comments (2 comments rather off subject!), 6 on Ibstock Spotted and 75 community/commercial venues. Copies of the responses are attached for reference.

A general flavour of the comments left by respondents are:

- Library needed for children
- Need to keep open
- Never should happen [closing]
- Valuable asset/resource
- Social meeting place
- Good for/part of community
- Books should be available for all
- Need more youth services
- Central place for learning is vital for local people
- Books are important from a young age
- Needed by all
