Cabinet Meeting 15 July 2025 Agenda Item 9 – Leicestershire County Council's Approach to Flooding

With the additional money being allocated to support flooding protection I would like to inform the cabinet of the following:-

In and around Melton we have several flood risks that would benefit from additional monies being spent on protection.

I had the opportunity to take a trip on the river Eye with Melton and Oakham Waterways Society, and they were showing me the extent of silting and bank vegetation encroachment, fallen trees and branches and various other blockages to the river. They are a voluntary organisation and are not able on their own to keep the river free from blockage. Rivers are our first line of defence against flooding as they ultimately take any excess water away. If we don't look after the rivers then the likelihood of flooding is increased.

There is also a statistic that says every £1 spent on a town river creates £7 for the local economy through greater leisure use.

With the additional monies being available it would be a great opportunity for Melton if some could be diverted to the Melton area.

Cllr Tilbury, I would welcome the opportunity to show you the considerable efforts that are being made on the river Eye that I think would benefit from our support in whatever way we can.

Comments for Cabinet; Agenda Item 10

The County Council approved the revised Environment Strategy 2018-2030 on 8th July 2020. The vision of the Strategy is that 'Leicestershire County Council will minimise the environmental impact of its activities and will improve the wider environment through local action. We will play our full part to protect the environment of Leicestershire. We will tackle climate change and embed sustainability into what we do.'

In December 2022, the County Council adopted the 2030 Net Zero Council Action Plan and the 2045 Net Zero Leicestershire Strategy and Action Plan. The vision of the Net Zero Strategy is that 'In 2045, Leicestershire has ended its contribution to global warming and has adapted to the impacts of climate change. The transition to net zero has created a cleaner, greener Leicestershire for people, prosperity, and planet; supporting healthy, resilient communities, enabling sustainable growth, and enhancing biodiversity.'

Since these commitments were made, the Council has been subjected to an increasingly constrained financial position with a significant deficit forecast. In February 2024, considering this and the estimated increased resources required to reach net zero, the Council resolved to extend the net zero targets to 2035 for Council operations and 2050 for Countywide emissions, in line with the national target.

National legislation is in place to support the UK's transition to net zero – the Climate Change Act 2008 (2050 Target Amendment) Order 2019 commits the Government to a 100% reduction of greenhouse gas emissions by 2050 compared with 1990 levels.

The Council £2m carbon reduction reserve was set aside in 2022 to create a fund to pump prime new carbon reduction initiatives. The Leader of the Council has proposed that this reserve is reallocated from net zero activities to flooding initiatives and adapting services to mitigate the impacts of severe weather events.

The Leader of the Council has requested that the Council repositions the Council's approach to the net zero agenda, focussing on dealing with the impacts of climate change and extreme weather (e.g. flooding and extreme heat), wider projects that deliver financial savings and projects that deliver additional social, economic or environmental benefits, in support of the Council's Strategic rather than carbon reduction activities.

The main primary legislation in the United Kingdom, which aims to tackle climate change, is the Climate Change Act 2008 (the "2008 Act").

Whilst local authorities have used various statutory powers to participate in net zero projects, at present, there is no overarching legal duty on local authorities to contribute towards achieving net zero. However, there is a patchwork of obligations that require local authorities to take climate change into account in the performance of their functions.

Going forward, local authorities may be legally required to take positive action to combat climate change. The Environmental Targets (Public Authorities) Bill is currently before Parliament.

In summary, the proposal under consideration presently appears lawful. However, the Cabinet should have in mind that, in the coming years, Parliament may well expand the Council's legal duties.

I can not see anything in the report that mitigates this risk, and therefore, the Cabinet should think carefully about this proposal and make sure they have a plan in place if this legislation does become statutory.

Comments from Mr Andrew Innes CC

Cabinet Meeting 15 July 2025 Agenda Item 11 - Home Care for Leicestershire Procurement

Despite my numerous interventions I see that the proposal is still to issue out the expected rates per hour. This will not allow any movement downwards of prices.

I asked at the Scrutiny committee about the reasons for the rapid increase in costs (taking out the growth in the usage). I suggest that the cabinet are given a detailed breakdown of the cost per hour since 2020 showing the increase per hour over the intervening period. Alongside it would be good to see the reasons for the increase per hour.

My concern is that our suppliers are comfortable with the rates, comfortable with the lack of direct quality control, the lack of monitoring of actual hours attended, and comfortable with the proposed length of the contract... (8 Years but with Breaks)

I have now had 3 meetings to discuss this and yet there appears to be very little movement from the original proposal. Care companies are in a very privileged position, and we need to make sure that they are viable, offer good quality, reliable and honest, but not at any cost. I see many care owners are quite wealthy individuals, and I do not have any objection to this, but I don't want then to become wealthy on the back of local taxpayers. This is not a dig, just an observation.
