The Leicester, Leicestershire and Rutland Police and Crime Panel (the PCP) on 30th October 2025 held a Confirmation Hearing to review the proposed appointment of Ms Neetu Squire to the post of **Deputy Police and Crime Commissioner (DPCC): Community Cohesion (0.2FTE)** for the Office of the Police and Crime Commissioner, in accordance with the provisions of the Police Reform and Social Responsibility Act 2011.

The Panel advised that there would be some training/onboarding needs in relation to her new role and understood that she will continue to develop the knowledge and skills needed to help the Commissioner deliver his Police and Crime Plan. In particular, it would be important for her to develop and deepen her understanding of, and relationships with the full diversity of communities and stakeholders across the whole of Leicester, Leicestershire and Rutland, not just the city area, and across all age groups.



This report gives the recommendation(s) made by the Leicester, Leicestershire and Rutland Police and Crime Panel in accordance with Schedule 1 of the Police Reform and Social Responsibility Act 2011. Its purpose is to outline the Panel's recommendations following a review of the proposal made by the Police and Crime Commissioner to appoint Ms Neetu Squire to the position of Deputy Police and Crime Commissioner: Community Cohesion (0.2FTE).

Hearing: On 15th October 2025 the Leicester, Leicestershire and Rutland Police and Crime Panel received notification of a decision from the Police and Crime Commissioner to appoint Ms Neetu Squire to the position of Deputy Police and Crime Commissioner: Community Cohesion (0.2FTE). During the hearing, which included an interview with the candidate, the Panel had regard to the information submitted about the candidate, the criteria used to assess the suitability of the candidate for the appointment and the terms and conditions on which the candidate was to be appointed.
