<u>APPOINTMENT OF INDEPENDENT PERSONS</u>

REPORT OF THE CHIEF EXECUTIVE AND THE DIRECTOR OF CORPORATE RESOURCES

Purpose of report

1. This report concerns the appointment of Independent Persons to support the Member Conduct Complaints Process as required under Section 28 (7) of the Localism Act 2011 and to support the procedures for dealing with the dismissal of the Chief Executive, the Monitoring Officer and the Chief Financial Officer, as required by the Local Authorities (Standing Order) England Regulations 2001 (as amended).

Policy Framework and Previous Decisions

- 2. The Localism Act 2011 sets out provisions regarding the conduct of members. It is a requirement under this Act that the Council appoint at least one Independent Person, whose view must be sought and taken into account by the Authority before it makes a decision on any allegation and whose views may be sought about allegations.
- 3. The Local Authorities (Standing Order) England (Amendment) Regulations 2015 set out a new procedure for dealing with the possible dismissal of the Chief Executive, the Monitoring Officer and the Chief Financial Officer and this was adopted by the County Council on 8 July 2015.
- 4. At its meeting on 28 September 2016, the Council appointed five Independent Persons for a period of four years to form a Panel from which any one could be contacted to advise on particular allegations.
- 5. At its meeting on 12 June 2020, the Corporate Governance Committee agreed to undertake a joint recruitment process with the Leicester, Leicestershire and Rutland Combined Fire Authority for the appointment of Independent Persons from 30 September 2020 for a term of four years.

Background

6. The Independent Persons appointed by the County Council in 2016 were appointed for a period of four years. With their terms of service due to expire in September 2020, a new joint recruitment process was undertaken in July with the Leicester, Leicestershire and Rutland Combined Fire Authority (CFA). The position was publicly advertised and an interview process undertaken to recruit a pool of Independent Persons to support both organisations' member complaints process and the dismissal process for senior officers as outlined above. The Interview Panel

consisted of Members drawn from the Corporate Governance Committee and the Employment Committee of both the County Council and the CFA, supported by the Assistant Director of Corporate Resources – Corporate Services and the Head of Law (the Deputy Monitoring Officer).

7. The Committee on Standards in Public Life completed a review into Local Government Ethical Standards and the recommendations are still being reviewed. When these have been finalised, the Council will adapt recruitment processes for Independent Persons accordingly.

Proposed Appointments

- 8. Whilst the Council previously appointed five candidates, a pool of six candidates is recommended for appointment for the four-year term from 30 September 2020 to cover the joint role of supporting the County Council and CFA, to allow greater flexibility and to avoid the possibility of a conflict of interest. All those recommended are eligible, live in Leicester or Leicestershire and are considered suitable candidates.
- 9. The regulations permit independent persons to be reappointed. The Monitoring Officer wrote to both the CFA's and the Council's existing appointees to thank them for their work to date and confirm that they were welcome to re-apply. Three of the six proposed appointees are existing Independent Persons for either the CFA or the County Council.
- 10. The Appointment Committee met on Friday 4 September 2020 to interview candidates and agreed to recommend the following people for appointment:-

Richard Gough Gordon Grimes Tina Herring Hema Kotecha Surinder Sharma Pamela Roberts

Further details of the above candidates are set out in the Appendix to this report.

11. Candidates will be appointed for a term of four years until 30 September 2024.

Resource Implications

- 12. By running a joint recruitment process for both the County Council and the Leicester, Leicestershire and Rutland Combined Fire Authority, economies of scale have been achieved through reduced advertising costs, officer administration time and the servicing of a joint recruitment Panel.
- 13. Any payments made to the independent persons appointed, for travel and subsistence expenses (where appropriate), will fall outside the Members Allowance Scheme which only applies to either elected or co-opted members of either Authority. An allowance will not be paid.

Timetable for Decisions

14. A report seeking approval to appoint the six Independent Persons detailed in paragraph 10 will be considered by the County Council on 30 September 2020.

Recommendation

15. That the Committee recommends the County Council at its meeting in September 2020 appoint Richard Gough, Gordon Grimes, Tina Herring, Hema Kotecha, Surinder Sharma and Pamela Roberts to serve as Independent Persons for a term of four years ending on 30 September 2024.

Mr Richard Gough

Mr Gough has been an Independent Person for the Combined Fire Authority since 2012 and was also appointed in the same year, as an Independent Person by Leicestershire Borough and District Councils. Mrs Kotecha has worked in police forensics for over 13 years and currently works for Dorset Police. She has a wide range of skills including investigating, analysing information, compiling evidence and ensuring that standards are maintained. She lives in Kibworth.

Prof. Surinder Sharma

Prof. Sharma has been an Independent Person for the County Council since 2012. He has wide ranging experience gained from working in the public, private and voluntary sectors, has been Chair of the Equal Opportunities Commission, a Magistrate and an elected member of a local authority. He is currently Chairman of the Leicester Racial Equality Council. He lives in Stoneygate.

Ms Pamela Roberts

Ms Roberts, a retired Civil Servant, has a wide career in public service, including in local government. She has a wide experience of policy formation and delivery, planning and ensuring that standards are maintained. She currently volunteers as a Trustee at a local charity. She lives in Market Harborough.

CONSTITUTION COMMITTEE: 18TH SEPTEMBER 2020 CHARITABLE TRUST FUTURE ARRANGEMENTS REPORT OF DIRECTOR OF LAW AND GOVERNANCE

Purpose of Report

 The purpose of this report is to update the Committee on the proposals for the future arrangements for the Educational Trusts of which the County Council is the sole corporate Trustee and to seek the Committee's approval to the closure and transfer of funds referred in paragraph 6 below into a single fund called the Leicestershire Educational Trust Fund to be administered by the Leicestershire and Rutland Community Foundation (LRCF).

Policy Framework and Previous Decisions

2. Part 3 of the County Council's Constitution provides for the Constitution Committee to undertake those functions relating to the Council's role as a charitable trustee. The Committee resolved at its meeting in July 2019 to approve the principle of the transfer of educational trusts to the Leicestershire and Rutland Community Foundation.

Background

- 3. The County Council is the sole corporate Trustee of various Educational Trusts set out below. Most of the Trusts have not been subject to a review for a significant period and the interest from the funds has accumulated over the years. Many of the Trusts are relatively small and the Trust objectives are difficult to apply. Engagement took place with the LRCF as part of the scheme supported by the Charity Commission to reactivate inactive Trusts for the benefit of the community. This coincided with approaches from the Charity Commission seeking the Council's proposals for the Trusts.
- 4. The Committee approved the principle of the Trusts being subject to closure and the funds being transferred into a fund to be administered by the LRCF combined into a single fund called the Leicestershire Educational Trust Fund, subject to developing qualifying criteria for the Trusts.
- 5. To progress the recommendation referred to above, a proportionate engagement exercise took place with a dual approach. Firstly those schools (or their successor bodies) which may have been referred to in the original Trusts were contacted for their views and these are reflected in the proposals in the table below. Secondly, a representative randomly selected sample of fifteen schools across all sectors and including maintained and academy schools, mainstream and special schools as well as faith VA schools were written to seeking comments and views on the general principles of the proposed transfer referred to above. There was a very limited response. Two schools did respond to express support to the transfer to LRCF citing the greater opportunity that

this would present to access funds and the benefits this would present for students who have SEND or mental health issues or other vulnerabilities.

Proposal; Leicestershire and Rutland Community Foundation

- 6. LRCF is a charity which helps local individuals and companies to give money, in a tax efficient way, directly to local needs. It offers a structure under which community, trust and donor funds are invested and managed in a consolidated fund. It currently manages £3 million of endowment funds on behalf of various charitable trusts and national grant programmes. LRCF operates by offering a moderate risk investment strategy which will preserve the capital (or achieve modest growth) and generate an annual return of 4% per annum to be used for grant making.
- 7. Based on the engagement above, it is proposed to close the funds listed in paragraph 8 below and to transfer £270,661 to LRCF to establish the new fund. Preparatory work has been undertaken in relation to the Fund Agreement Transfer which is now ready to be executed. The funds are currently invested with CCLA and the LRCF use the same investment fund and it is proposed to transfer the funds without withdrawing them as this will avoid the costs associated with buying and selling. The new trust will be called the 'Leicestershire Educational Trust' and members will retain involvement through the submission of an annual report to the Constitution Committee on the operation of the trust by the LRCF as previously agreed.
- 8. The benefits of this approach as outlined in the previous report are as follows:
 - a. The active management of the Trusts and making grant awards would support the community and be in keeping with the wishes of the donors:
 - b. The administration of the Trusts at present is achieved through the internal services and via professional support from Corporate Resources and the Chief Executive's Department. The resource involved in maintaining the Trusts is not significant but if the Trusts are to be actively managed this would require additional resourcing;
 - c. It meets the objectives of the Charity Commission trust revitalisation initiative:
 - d. LRCF is an accredited member of the UK Foundation Network and is experienced in managing educational trusts elsewhere, such as for Leicester City Council, and offers a resilient approach;
 - e. Members retain involvement through receipt of an annual report on grant giving and the operation of the Trust; and
 - f. It is consistent with the advice to Local Authorities from the Charity Commission to review and consolidate small funds.

Resource Implications

10. LRCF's running costs are met through fees charged for managing and administering the funds and also from private sector donations. The set-up fee is 5% and annual fees are negotiated between 1-3%. There are no costs to the Council in connection with the LRCF proposal.

Recommendations

- 11. The Committee is recommended to:
 - a) Approve the closure of the Trusts referred to in para 8 above and the transfer of assets into a trust to be administered and managed by the Leicestershire and Rutland Community Foundation and to authorise the Director of Law and Governance take any steps necessary to achieve this.
 - b) Request the Leicestershire and Rutland Community Foundation to submit an annual report to the Constitution Committee on the operation of the Fund.
 - c) Authorise the Director of Law and Governance to explore the future arrangements for the trusts referred to in para 9 above and to report back to this committee.
