## 1) Electoral Division activities

## Main Activities and the impact during the past year:

During the past 12 months I have assisted numerous residents across a wide range of issues such as highways, parking, school admissions and transport to school.

Whilst it has not always been possible to resolve the issues raised, I do believe that in those cases I have fully explained why this has not been possible and the reasons behind the decisions that have been made. This process has necessitated working with officers and fellow members especially portfolio holders which has further increased my breadth of knowledge which will assist in providing speedier responses to residents where similar situations occur.

In my Division I have two Parish Councils one of which I have been a member for thirty years and the other which I attend on a regular basis. I use these meeting to bring members and residents up to date which current issues and to seek feedback. The is a very positive relationship which ensures residents know both how to contact me and what the role of a County Councillor entails.

In addition as Leader of Blaby District Council representing a ward which is 90% within my County Division Boundary I am able to differentiate between the three tiers and ensure that questions and feedback from residents is disseminated to the right body.

A major topic of discussion in the past year has been the Strategic Growth Plan and I have been able to use the composite knowledge I have gained to provide information on what is trying to be achieved at all levels.

# Engagement with the Council, other statutory bodies and public utility companies (Water, Gas etc) about services in the area

This has largely been covered in the previous section but during my time and through my role on the Scrutiny Commission I have been able to engage with utility companies, faith bodies and a wide range of other organisation especially across the Charitable sector. This has resulted in a useful two way dialogue to more appropriately ensure that services meet the needs of residents and to ensure that residents understand what they might be entitled to.

To carry on with the work I am already doing which does make a difference to people's lives and which strengthens my resolve to demonstrate that politicians are just ordinary local people who share the same concerns as our residents and who are just seeking to improve all our lives
