1) Electoral Division activities

Main Activities and the impact during the past year:

As a new County Councillor I try to attend as many Parish Councils as I can but make myself available to all Parish Councils to help with their problems.

Some of the problems I have been able to help the Parish Councils and constituents with have related to road safety, crossing busy roads, speeding traffic, bus services for children, loss of bus services, unsafe roads, unsafe pavements and footpaths, overgrown hedges, new planning applications, problems with access to local schools, a desperate need for more and better parking, and support to high street traders.
