



## **LEICESTERSHIRE LOCAL ACCESS FORUM – OCTOBER 2018**

### **REPORT OF THE DIRECTOR OF ENVIRONMENT & TRANSPORT ON PUBLIC RIGHTS OF WAY LEGAL ORDERS AND OTHER ONGOING CASES**

#### **Purpose of Report**

To update Forum members on the current position with regard to various Public Path and Modification Orders since the last such report in April 2018.

#### **Public Footpath Orders which have been confirmed since the last report**

1. A list describing the Public Path Orders which have been confirmed since the last report in April 2018 is attached as Appendix 1 together with associated plans attached as Appendices 2-13.

#### **Public Path Order Applications**

#### **Referrals to the Planning Inspectorate, Public Hearings & Inquiries**

5. The Order extinguishing Bridleway I20 (Barrow Crossing) has been referred to the Secretary of State for determination. A date for the Public Inquiry has not been finalised but is unlikely to occur before June 2019. (See Appendix 48)

## **Decisions Received**

6. There have been no new Planning Inspectorate decisions since the last report.

The County Council's Development Control and Regulatory Board decided, at its September meeting that two Modification Orders should be made:-

**M970 – Addition of a Public footpath along the disused railway line between Lubenham and Market Harborough (passing through Northamptonshire).** (See Appendix 49) This route was claimed by the AdamSmile Charity and is solely based on user evidence.

**M1038 – Addition of a Public Footpath to Read's Close, Slawston.** (See Appendix 50) This is a claim based on user evidence which was supported by historical maps.
