## 1) Electoral Division activities

#### Main Activities and the impact during the past year:

A key issue has been the implementation of traffic calming schemes for LFE and Kirby Muxloe from the s106 mitigation funds for the new Lubbesthorpe development. Public consultations were held in each parish and having visited both I found a 50 / 50 split of views accepting that calming was needed, but not necessarily as per the initial proposals being tabled. Attended a meeting held at County Hall with Kirby Muxloe Parish Council to look at an alternative provision which was of great interest.

Glenfield has seen an increase in speeding related issues along its main roads and these have been reported and passed on to the officers. The ongoing developments to the south of the Village have seen many changes to infrastructure provisions as well as the mix of the village. This has added to the usage of the roads in and out of the village.

I have attended meetings at all Parishes and if not in attendance, I am available to listen to all problems and assist if they are County related.

I attended the Annual Thurlaston Parish Awards evening and was impressed with the community spirit within this small village.

Dealt with, including signposting, many individual resident's issues across the four Parishes. I have a good working relationship with Richard Blunt the other Divisional Member. We try and keep up to date with and for input into the local publications to ensure we are able to give a local update to our workloads, if and where possible.

# Engagement with the Council, other statutory bodies and public utility companies (Water, Gas etc) about services in the area

Have been keen to promote all County Council initiatives across the Division. Have replied to consultations including bus services that affect the Division and ensured that the Parishes are aware of these consultations.

#### **Committees you serve on at County Hall**

For the second year of office, I have been appointed as Lead Support Member for Adult and Social Care which incorporates Libraries, Museums and Heritage. I retain my Vice Chairman of Pensions Committee.

I now represent County Council on the Adults Safeguarding Board and the Health and Wellbeing Board through my role as Lead Support Member. I also sit on the Police and Crime Panel as a Representative of Blaby District Council.
