# <u>LEICESTERSHIRE COUNTY COUNCIL'S REVISED STRATEGIC</u> <u>PLAN 2018 - 22</u>

# REPORT OF THE CHIEF EXECUTIVE

# PART A

## **Purpose of the Report**

1. The purpose of this report is to present the outcome of consultation on the County Council's revised Strategic Plan 2018-22, which has been amended to reflect the Council's declaration of a climate emergency in May 2019 and seek approval for the Plan to be submitted to the County Council for consideration.

### **Recommendations**

- 2. It is recommended that:
  - The outcome of consultation on the Council's revised Strategic Plan be noted;
  - b) That the County Council at its meeting on 8 July 2020 be recommended to approve the revised Strategic Plan 2018 22.

#### **Reason for Recommendations**

3. To enable the revised Strategic Plan to be considered by the Council at its meeting on 8 July 2020. The revised Plan sets out an approach which will put outcomes for people first, support integration across the Council's services and make better use of the total resources available to the Council whilst ensuring its commitment to Leicestershire is in line with its declaration of a climate emergency in May 2019.

# **Timetable for Decisions (Including Scrutiny)**

- 4. The revised Strategic Plan was presented to the Environment and Transport Overview and Scrutiny Committee on 5 March 2020 and to the Scrutiny Commission on 8 April 2020. Their comments are summarised in Part B of this report.
- 5. As the Strategic Plan is part of the Authority's Policy Framework (as defined in the Constitution) the revised Plan will need to be approved by the County Council. It is intended that it will be submitted to the Council for consideration on 8 July 2020.

## **Policy Framework and Previous Decisions**

- 6. In April 2016, the Cabinet approved a refresh of the Strategic Plan including the development of a Single Outcomes Framework. The Strategic Plan, covering the period 2018 – 2022, was approved by the County Council in December 2017.
- 7. In response to the County Council's resolution to declare a climate emergency in May 2019, the Cabinet agreed in September 2019 that the Council's Strategic Plan covering the period 2018-2022 and Single Outcomes Framework would be revised to incorporate the new environment and climate change commitments. This was completed alongside a review of aspects of the Environment Strategy 2018 – 2030.
- 8. The Strategic Plan is underpinned by a number of other key policies and strategies to form the strategic policy of the Council including the Medium-Term Financial Strategy and the Environment Strategy.

## **Resource Implications**

- 9. The Strategic Plan objectives are broadly reflected in the Council's Medium Term Financial Strategy(MTFS). As more detailed actions are developed these will be reflected in future iterations of the MTFS.
- 10. The Council agreed £16m worth of investment in the Medium-Term Financial Strategy 2020 – 24 to respond to its climate change commitments.
- 11. The Director of Corporate Resources has been consulted on this report.

# PART B

# **Background**

- 13. The Strategic Plan outlines the Council's long-term vision for the organisation and the people and place of Leicestershire. It provides a simple and clear summary of the Council's direction over the four years.
- 14. The Plan is underpinned by other key policies and strategies including the Medium-Term Financial Strategy and the revised Environment Strategy which will also be considered by the Cabinet at its meeting in April.

## **Strategic Plan - Revisions**

- 15. The Plan has been reviewed to enable the County Council's to meet its ongoing commitment to protect and enhance the environment and to recognise the urgent need for accelerated action to avoid the worst impacts of climate change.
- 16. The revised Strategic Plan now reflects the climate emergency declaration during the remaining years of the current Plan. The following are the main changes to the plan:
  - a. Revised Council Vision and supporting text to reflect the Council's declaration of a climate emergency and align with the new strategic and supporting outcomes
  - b. A new separate and strengthened environment principle which acknowledges the net zero carbon target for the council's operations by 2030;
  - c. Revised strategic and supporting outcomes to embed environmental ambitions across all outcomes;
  - d. Updated narrative text throughout the document: Foreword, Introduction, and the outcome descriptions to reflect the Council's commitment to environmental protection
  - e. A new "Our Approach" section entitled 'Tackling climate change and ecological decline';
  - f. Updated section on "Working across the council" to reflect the new Strategic Change Portfolio;
  - g. The "Measuring success" section has been amended to reflect the increased emphasis on environmental performance, with environmental indicators embedded across the relevant outcomes. Other changes have been incorporated to reflect changes in national and local reporting frameworks.

# **Strategic Outcomes – Revisions**

17. The Council's vision statement, included in the Strategic Plan, is: "Working together for the benefit of everyone."

- 18. It states that 'The Council is here to make a positive difference to the lives of Leicestershire people. This vision captures what the Council wants for Leicestershire and what type of organisation it strives to be over the next 20 years.
- 19. The Authority wants Leicestershire's economic prosperity to support resilient clean growth that creates the best life chances for all. Leicestershire is a place where people are well and safe, living in a healthy environment as part of great communities where people enjoy life and work together to enhance their local area. There is a good supply of quality, sustainable homes that provide maximum independence and are affordable to own and run'.
- 20. The five strategic outcomes, which support the vision in the Plan, have been amended to embed the Council's environmental commitments. The five outcomes are as follows:

## a) Strong Economy

Leicestershire's economic prosperity benefits everyone and supports resilient, clean growth

## b) Wellbeing and Opportunity

The people of Leicestershire live in a healthy environment and have the opportunities and support they need to take control of their health and wellbeing.

# c) Keeping People Safe

People in Leicestershire are safe and protected from harm.

#### d) Great Communities

Leicestershire communities are thriving and integrated places where people help and support each other and take pride in their local area.

#### e) Affordable and Quality Homes

Leicestershire has a choice of quality, sustainable homes that people can afford.

- 21. The Plan also includes the following principles which will shape the Council's approach and define how it works as an organisation to achieve the vision.
  - a) **Good Value**: We make the best use of all the resources available to get the best return for Leicestershire
  - b) **Informed**: We make good decisions, based on evidence, and try new things to drive innovation in public service
  - c) **High expectations**: We have outstanding staff who aim high to make a real difference focusing on the outcomes for people not just the delivery
  - d) **Collaborative**: We work together with partners, communities and residents to share responsibility, build our strengths and find solutions

- e) **Open**: We listen to and empower local people; keep them informed and involve them in our plans
- f) **Responsible:** We will fulfil our leadership role for the environment; taking action to be carbon neutral by 2030 and reverse the decline in biodiversity
- g) **Fair:** We are committed to equality of opportunity, celebrating diversity and inclusion for all

## Measuring and reporting progress

- 22. The performance section has been amended to incorporate an increased emphasis on environmental performance, with environmental indicators embedded across the relevant outcomes. Other changes arising from national and local reporting frameworks have also been included.
- 23. The new performance tables by theme include over 170 proposed metrics and provide a framework of key indicators to be embedded in existing data reporting arrangements. The outcome measures inevitably reflect some areas where the Council does not have direct control and elements that 'tell the story' of what life is like in Leicestershire. This will allow progress against the outcomes for the population of Leicestershire to be monitored, as well as the effectiveness of the Council's programmes and how the Council has performed as an organisation in deploying resources to achieve the required changes.
- 24. Regular reports on performance will be presented to the relevant County Council Scrutiny Committees to ensure that progress and delivery is on track for each theme. An integrated annual delivery report and performance compendium looking at the themes and outcomes will also be reported to Cabinet, Scrutiny Commission and full County Council each year and made publicly available. This will include benchmarking of the Council's data and performance against other comparable areas and analysing integrated data, where relevant, with partners.

# **Consultation with Scrutiny bodies**

- 25. The Environment and Transport Overview and Scrutiny Committee was consulted on the revised Strategic Plan on 5 March 2020. The Committee broadly welcomed the Plan reflecting the Council's commitment to take Climate Change seriously. The Committee emphasised the importance of partnership working and requested that further consideration be given to how this could be achieved and asked that it be ensured that the performance framework relating to air quality was suitably inclusive to a variety of air quality metrics.
- 26. The Scrutiny Commission was consulted on the Strategic Plan on 8<sup>th</sup> April 2020. The Commission strongly supported the environmental enhancement of the Plan but raised concerns relating to the delivery of its ambitions in the short to medium term given the current and future pressures that could be expected to fall on planning authorities because of the coronavirus. It was agreed that these issues were best addressed by the Environment Strategy and its related action plan.

- 27. The Commissioners also highlighted the impact that the COVID-19 pandemic would have on the assumptions made when developing the Plan. They requested that this should be acknowledged and that the intention to review and update the plan during 2021/22 when the consequences of the pandemic are more stable and apparent should be emphasised.
- 28. A copy of the full minute from the meeting of the Scrutiny Commission is attached as Appendix B to this report.
- 29. The comments received from the Environment and Transport Overview and Scrutiny Committee and Scrutiny Commission have been reflected in the revised Strategic Plan.

# **Developing a new Strategic Plan**

30. The current global situation created by the COVID-19 pandemic will impact on many of the assumptions made during this revision of Strategic Plan 2018 - 22. A detailed review of the Plan will begin later this year/early next year which will take account of all the circumstances and outcomes arising from the coronavirus outbreak
