This report summarises the activities of the following member of the County Council during 2019/20

1) Electoral Division activities

Main Activities and the impact during the past year:

During the past year I have served as a Scrutiny Commissioner, and a member of the Local Pensions Committee. In doing so I have scrutinised the activities of the Authority, contributed to good governance over policy decisions and brought my finance experience (from the private sector) to the benefit of the Authority.

I continue to attend and work closely with all four parishes in the Division (Markfield, Desford, Bagworth & Thornton, and Stanton under Bardon) particularly on prospective planning applications – of which we have seen a significant increase in the year.

I continue to chair the Bardon Hill Quarry Community Fund where we promote applications from in and around Markfield for schemes that would better the environment for local people.

I have assisted over 50 residents through casework on a range of issues including: flooding, speeding, parking enforcement, to queries over education and health/social care.



I continue to attend Parish Council Meetings via Zoom

- Markfield: Campaigned against extension of the dispatch and delivery times of Crown Crest (Desford) that would have a detrimental impact on the amenities of local residents resulting from increased HGV traffic.
- Desford: Highlighting the need for speed reduction measures and working with the Parish Council on solutions to local highways issues.
- Bagworth & Thornton: Chaired a public meeting of County, Borough, Parish, Severn Trent, and Police representatives on finding a workable solution to the parking issues around the Reservoir.
- Stanton under Bardon: Supporting local residents in their opposition to the Bardon Three Development which is in close proximity to the village. In doing so I have attended resident meetings, met with Borough Councillors, corresponded with the applicants and involved the Member of Parliament in championing the case of residents.



Working closely with Borough Councillors on issues that straddle both Borough and County Authority matters.

Engagement with the Council, other statutory bodies and public utility companies (Water, Gas etc) about services in the area

- I have monthly meetings with Severn Trent Water on developing solutions to the Parking Issues experienced at and around Thornton Reservoir.

Priorities for the immediate future are:

- Support local voluntary and community groups such as the Markfield Good Neighbours (MGN), and the Desford Good Neighbours/In Bloom schemes as they support those impacted by the Corona virus pandemic;
- Campaigning for 'sustainable development' by opposing housing schemes that would have a detrimental impact on the quality of life of local residents;
- Improvements in the enforcement of parking issues for rural communities such as those in Thornton (which is heavily impacted by the Reservoir);
- Campaigning for safer 'routes to schools' such as the walk from Markfield village to The South Charnwood High School;
- Support 'cleaner, greener' initiatives for rural communities by promoting greater use of green space for recreation and sporting activities.
