1) Electoral Division activities

Main Activities and the impact during the past year:

In addition to my primary role as the elected County Councillor for the Bruntingthorpe Division, my main activities throughout the year have been as a Member of the LCC cabinet with responsibility for the Environment and Transport department.

During March 2020, I was appointed acting Deputy Leader of the Council, with a new portfolio focussing on the Council's commitment to take action on climate change, deliver our aim to be carbon neutral by 2030, the Environment and recycling agenda, superfast broadband delivery, Trading Standards and Regulatory Services and Minerals and Waste planning.

In July 2020 I was elected Deputy Leader of the County Council.

The COVID 19 crisis has had a profound impact upon the annual programme of work at LCC and has needed all of mine and my colleagues' focus and attention since March. The human, environmental and financial implications of the pandemic will also have a changing and lasting impact upon the business of LCC moving forward, particularly our finances and £600M capital infrastructure programme.

Whilst as lead member for the E&T department over the past year, I'm pleased to report the following achievements:

- Preparation of a new Environment Strategy that pledges to commit the authority to achieve 'net zero carbon' by 2030.
- Delivery of a new service level offer and extra resources to benefit Leicestershire Parishes and Communities through a new initiative called 'Keeping it Local'
- Delivery of a new Recycling and Household Waste site offer with a focus on setting up new 'Re-Use' centres.
- The enablement of various successful schemes which have been bid for and delivered locally, which can also be claimed as achievements, by colleagues and councillors from other organisations.
- A departmental focus cracking down on speeding and irresponsible parking outside schools, keeping our communities safer.
- Maintaining Leicestershire's status as having some of the best-maintained roads in the country despite reducing resources.

Priorities for the immediate future are:

My main priority is to ensure that residents of the Bruntingthorpe Division are properly represented at County Hall. The impact to services will be high, particularly extra costs for protecting vulnerable people, children's social care, SEND services, school transport, disposing of waste and investing in people and infrastructure projects. This means we will have to maintain our lobbying of MPs to ensure fair funding for Leicestershire. I also support a single unitary authority for the county to prioritise outcomes for people rather than structures of government. I'm very proud to lead the £16M project to reduce our carbon footprint, take action on climate change and become a carbon neutral organisation by 2030.
