## **SECTION 53 – WILDLIFE AND COUNTRYSIDE ACT 1981**

Proposed Addition of Public Footpaths C109 and C109a at Glen Oaks, Great Glen

Public Rights of Way are recorded on the Definitive Map and Statement. The Map and Statement provide conclusive evidence of the existence of public rights. Leicestershire County Council is responsible for the Definitive Map and Statement for Leicestershire and has a duty to amend it when evidence suggests that it is inaccurate or incomplete. Such amendments are made by Modification Orders made under Section 53 of the Wildlife and Countryside Act 1981.

Leicestershire County Council has received an application for a Definitive Map Modification Order, seeking to add two public footpaths. One path runs from Footpath C13 near Spinney View, Great Glen, to Oaks Road (eastern extension). The other path runs from the above mentioned route southwards through Glen Oaks to Oaks Road (southern section). The claimed routes are shown on the attached Plan No. M1134-C.

Before this application is considered by the County Council, I am undertaking preliminary consultations with local Councils, user organisations and interested parties. I would therefore be grateful if you could let me have your comments on this proposal by <u>Friday 16<sup>th</sup> August</u>.
