SPB Focus and Priorities for 2022/23

Core Purpose:

To provide system leadership and the strategic coordination required to prevent and reduce violence and vulnerability across Leicester, Leicestershire and Rutland. Board to focus on the areas of business which require a system-level response (e.g. LLR-wide, cross sector)

Responsible for:

- Discharging of shared legal duties including the forthcoming SV duty and VRN's core function to 'provide leadership and strategic co-ordination...'
- Providing the formal governance for VRN
- Agrees and owns relevant LLR-wide strategies (e.g. VRN/SV Response Strategy, SOC, Drugs, VAWG...)

2022 Priority: Reducing Violence and Vulnerability

Definition of Violence:

Embraces the WHO definition recognising the links between different types of violence and the common risk factors and causes

"The intentional use of physical force or power, threatened or actual, against oneself, another person, or against a group or community, that either results in or has a high likelihood of resulting in injury, death, psychological harm, maldevelopment or deprivation". (WHO, 2002)

Domestic Abuse, Sexual Violence and Public Place Violence


Approach:

Three Sub-Boards

Prevention and Early Intervention Board

Purpose

To prevent the early onset of violence through strengthening known protective factors and ensuring relevant strategies/services are targeted at the populations/cohorts most at risk

Types of violence/ vulnerability

Example Areas of Business

Violence-related adverse childhood experiences including parental conflict, domestic abuse, bullying, offending in the family... others?

- Reducing and mitigating the impact of known sources of childhood trauma: e.g. parental imprisonment; parental conflict and domestic abuse
- Strengthening links between CJ and Supporting Families programmes/Early Help
- Evidence-informed parenting programmes for at risk groups
- Incorporating violence prevention knowledge and strategies into education/school and health sectors work
- Community education/awareness raising and involvement
- Trauma Informed LLR (lead)

Adolescence Safety and Diversion Board

To prevent and reduce involvement in violence through safeguarding, early intervention and diversion

CCE, CSE, Missing, County Lines, Public Place violence including weapon carrying/use (young people), early onset of intimate partner abuse

- Contextual/community safeguarding responses to exploitation and youth violence
- School attendance and inclusion for at risk groups
- Safer schools
- Cross sector youth service responses
- Diversion (CJ and health settings) focusing on known risk/protective factors (e.g. gang membership, substance misuse, ETE, mental health, social skills etc)
- Oversight of VRN funded youth interventions
- Young person/parent education/awareness raising and involvement

Adult Vulnerability and Offending Board (MAPPA SMB)

To prevent recurrence of violence through deploying CJ responses and providing opportunities for rehabilitation and recovery

Domestic Abuse and Sexual Violence, OCGs, IOM and MAPPA offenders (stat board), NTE and other Public Place violence (adults), Modern Slavery?

- Tackles criminal drivers of serious violence (OCGs, weapon access, drugs)
- Substance Misuse Strategy (lead)
- DASV (lead)
- Cohort identification and management (lead)
- Alcohol/NTE related violence
- Evidence-informed interventions to prevent reoffending (group/individual)
- Victim services/responses
- Modern slavery
- Prevent
- MAPPA/IOM
