



County Councillor Betty Newton Annual Report 2021/22

The past 12 months have been a very busy time and have meant having to develop new ways of working and integrating with the community due to the challenges of COVID. Nonetheless, I managed to maintain a full programme of work including attendance at meetings (via zoom) and in person when possible.

In my role as a County Councillor, I hold a number of important and challenging positions including the following:

- member of the Employment Committee
- member of the Member Conduct Panel
- I also sit on the Combined Fire Authority
- Vice-Chair of the Corporate Governance Committee of the Combined Fire Authority
- Chair of the Strategic Equalities Group.

Full Council: Children and Families Scrutiny Meetings/Briefings.

As the Labour spokesperson for **Children and Families**, I attended all the meetings and briefings plus MTFS (Medium Term Financial Strategy) meetings. These included Care Leavers meetings where the topics under discussion included education, housing, finance and employment along with a session on the Dark Web. I also attended a Health Scrutiny briefing and asked a question about the role of elected members in ensuring children's health and well-being.

I attended (via zoom) meetings of the **Children's Social Care Panel** where there were discussions about bullying in schools and transphobic behaviour. This has become an important issue in recent years and at one meeting I tabled a question here about how robust teacher training was in dealing with the issue.

The plight of **Young Carers** has long been a concern of mine and I was pleased to be able to contribute to the Children's Scrutiny Committee discussion on the surrounding issues.

The tragic situation in **Ukraine** has been much to the fore in recent months and it was good to see it high on the agenda at briefings and meetings. There was much discussion on what we could offer in a positive way to those refugees seeking a new life here in the East Midlands. I contributed to an **All Member Briefing** on the plight of Ukrainian refugees.

Corporate Parenting is another issue I have long been involved with and I welcomed the opportunity to contribute to discussions on this topic at briefings and meetings. Corporate Parenting is the collective responsibility of the elected members of Council for providing the best possible care and safeguarding for the children in their area.

Submission to Cabinet

Along with another Councillor, I did a submission to Cabinet on the A6 North/A6004 route from Hathern to Loughborough in relation to traffic congestion along this road.

As a member of the Combined Fire Authority, I have worked as the Equalities Champion. We have won an award for our work on equalities. Also, attended a meeting to encourage more women to join the Fire Service.

I attended regular meetings of Sedip, a working group of Fire officers. I'm the Vice-Chair of the Committee on Fire Corporate Governance.

I always read the papers on behalf of the Labour Group and brief members on the issues and encourage them to ask relevant questions.

I was on the interview panel for the post of Chief Fire Officer as well as on the panel for deputy Chief Fire Officer. I even attended a Pension meeting when the Group Leader couldn't attend! I have held several briefings with the Chief Fire Officer to discuss important matters arising from meetings and as well as other issues.

I carried out my regular street surgeries, knocking on doors, when restrictions permitted. In addition to the street surgeries, I also carried out surgeries at the following locations:
