Electoral Division activities

Main Activities and the impact during the past year:

Aside from responding promptly to individual resident concerns, and signposting them to the correct part of the County Council, I have spent most of the past year on improving my understanding of the issues that are dealt with by the County Council in my division. I have managed to allocate all of the £25,000 members highways funds to much in demand VAS speed cameras in Foxton and Lubenham as well as some other minor highways works.

I have made representations to Highways on a number of applications within my division, and in particular worked with officers, local MP and others re the MOJ Prison application at Gartee.

I have also in relation to my division had discussions with the LLFA regarding surface water flooding issues across Market Harborough.

I have raised residents concerns about the impact on Cycle lanes caused obstruction by parked cars. As a result of a meeting with officers, they are looking at how TROs can be introduced into the areas with physical cycle lanes, especially in my division area.

Bus services- I have been involved in making numerous representations on Bus Service and changes, Arriva X3, Stagecoach X7, Centre Bus, 44, and 33 and in addition managed to secure meetings to raise those concerns with operators before they made changes. This is an ongoing area of work.

I've also raised and had various discussions about parked cars on streets blocking access by district waste collection lorries, emergency services and buses, and what can be done to inform local residents about the issues and look at what longer term solutions may be required. Finally, I have been closely liaising with teams at Harborough District Council on a wide range of issues.
