1) Electoral Division activities

Main Activities and the impact during the past year:

- Organisation and delivery of the Members Highways Fund, working with all 12 Parishes in the division.
- Campaigning to reduce speeding across the division and working with local community groups to support their campaigns to improve road safety.

- Organised meetings at County Hall for residents and community groups so officers can provide expert advice and information on local issues.

Engagement with the Council, other statutory bodies and public utility companies (Water, Gas etc) about services in the area

- Regular catch ups with the Cabinet Members for Highways, the environment, and Schools, plus lead officers to raise concerns of local groups and residents right across the division.
- Communication with Police and Crime Commissioner to raise issues on Community Safety and parking enforcement.

- More money and investment in highways, the environment and innovation.
- More funding for Leicestershire County Council.
- Effective delivery of the Members Highways Fund for another year.
