Annual Library Plan	No longer required. An annual position statement is produced and agreed with the Cabinet. (now listed as Plan (R) to be agreed by the Cabinet)
Children's Services Plan Early Years' Development and Childcare Plan Education Development Plan Behaviour Support Plan	These are now subsumed in the Children and Young People's Plan (Listed as Plan No 4 on the revised schedule).
Local Agenda 21 Strategy	Not produced as a separate document but integrated into the Community Safety Strategy. (Plan 3 on revised schedule)
Quality Protects Management	Subsumed within the Children and Young People's Plan.

Central Leicestershire Retail Strategy	No longer produced as a separate document – subsumed within plans and strategies produced by the LSEP

Nature Conservation Strategy	No longer produced – the Biodiversity Action Plan which is a plan approved by the Cabinet now incorporates the key actions previously included in this Plan.
Sports Strategy	The County Sports Partnership now has responsibility for producing a Strategic Framework Document for the County and Rutland, which it is suggested the Cabinet should agree.
Adult Learning Plan.	There is no longer a requirement to produce this Plan.
Food Law Enforcement Service Plan	No longer required. An annual update will be provided to the Cabinet. (now listed as Plan (S) to be agreed by the Cabinet)
