

# LOCAL PENSION COMMITTEE – 18 NOVEMBER 2022 REPORT OF THE DIRECTOR OF CORPORATE RESOURCES PENSION FUND POLICY REPORT

# **Purpose of the Report**

1. The purpose of this report is to provide an annual update of the Pension Fund's current strategies and policies and seek the Local Pension Committee's approval of a new Cyber Policy.

## **Background**

- 2. The Local Pension Committee is responsible for the governance of the Leicestershire fund, which includes setting policies to be included in statutory documents.

## Pension Fund Budget and Business Plan

5. The Pension Fund Budget and Business Plan was approved by the Local Pension Committee on <u>25<sup>th</sup> March 2022</u>.

## Cyber Policy

6. A new policy outlining the Fund's approach to Cyber Risk has been developed and is included as the appendix to this report. Fund officers worked with the County Council's Technical Security Officer to ensure that the policy can demonstrate that the Fund has robust governance arrangements in place and to provide assurance to the Fund's stakeholders that any risks are well managed.

The policy covers actions in respect of systems, particularly the Altair network of systems provided by Heywood (the main administration systems used by the Pension Section). The policy covers the checks Officers have in place to ensure regular Cyber Security checks continue to be performed, and the processes that Heywood have in place with regards to combatting Malware attacks.

The policy also covers the processes in place for staff. Many of these align with the Council's policy, including actions taken in respect of any data breaches, password controls and sending emails securely.

#### **Other Policies**

7. In addition to the policies covered in this report, the Net Zero Climate Strategy, Investment Strategy Statement and the Funding Strategy Statement are addressed in separate reports at this Committee.

#### Recommendation

8. It is recommended that the Local Pension Committee approves the Cyber Policy.
