Electoral Division activities

Main Activities and the impact during the past year:

During the last 12 months, I have continued to ensure that I responded promptly to resident and parish council concerns. After further resident representations I decided to allocate the 2nd tranche of the members highways fund towards parking restrictions on Walcote Road, Market Harborough which has been blighted for a number of years with all day commuter parking. In addition I have worked with officers to see how we can ensure that the cycle lanes on Coventry Road and Fairfield Road can be used by cyclists instead of being parked on by cars.

Continued to work with various stakeholders, parish councils, district cllrs and local MP and county officers on the Gartree Prison application which went to appeal. Now subject to a call in by the Secretary of State.

Public transport both along the A6 and A4304 and around the local villages of Foxton and Lubenham are an ongoing concern. A number of meetings have been held with bus operators along with LCC officers to explore how we can ensure that the bus timetables more appropriately meet the needs of service users.

A further issue that I have received a substantial amount of case work on is related to SEND and home to school transport provision. These have resulted in me submitting questions to the appropriate scrutiny committee on their behalf to obtain further clarifications and this has helped myself and other colleagues have a better understanding of the contractual arrangements that are in place for these services.

In addition to this I have been working on the Health Scrutiny and Oversight for the past year to ensure greater transparency by the local NHS services to their plans, success and how they intend to improve delivery across LLR.

Flooding- championed the review of the surface water flooding issues in my division

Delivery of infrastructure- roads, schools etc – working with parishes and local residents to understand when delivery will happen.

Neighbourhood Planning- supported the creation of the Market Harborough Town Forum by Harborough District Council to create multiple neighbourhood plans for the unparished areas of my division.

Worked with my neighbouring CC member and officials re the revised Market Harborough Transport Strategy

I have continued to ask questions at Committees and Council, that are relevant and topical to my division.
