**MEDIUM TERM FINANCIAL STRATEGY 2024/25 TO 2027/28 -  
PROPOSALS FOR CONSULTATION**

**REPORT OF THE DIRECTOR OF CORPORATE RESOURCES**

**Purpose of the Report**

1. The purpose of this report is to enable consideration to be given to the provisional Medium Term Financial Strategy for 2024/25 to 2027/28 (the MTFS) which incorporates the 2024/25 revenue budget and capital programme.
2. A supplementary report setting out the detailed proposals for the MTFS is currently being prepared and this will be circulated to members and published on the County Council's website as soon as it is available.

**Recommendation**

3. The Cabinet is asked to note this and the supplementary report and consider the Medium Term Financial Strategy for 2024/25 to 2027/28.

**Reason for Recommendation**

4. To enable the Medium Term Financial Strategy for 2024/25 to 2027/28 to be agreed for consultation and submission to the Scrutiny Commission and appropriate Overview and Scrutiny Committees.

**Timetable for Decisions (including Scrutiny)**

5. Subject to agreement by the Cabinet, the MTFS will be considered by the Scrutiny Commission and the Overview and Scrutiny Committees during January 2024, as follows -

Health - Wednesday 17 January

Highways and Transport - Thursday 18 January

Adults and Communities - Monday 22 January

Children and Families - Tuesday 23 January

Environment and Climate Change - Wednesday 24 January

Scrutiny Commission - Monday 29 January

6. It is intended that the Cabinet will then consider comments of the Scrutiny bodies and responses from the wider consultation process at its meeting on 9 February 2024 and the final MTFs will be submitted to the County Council for approval on 21 February 2024.

### **Policy Framework and Previous Decisions**

7. The MTFs is a rolling financial plan that is updated annually. The current MTFs was approved by the County Council in February 2023. The County Council's Strategic Plan outlines its long-term vision and the MTFs, along with other plans and strategies such as the Transformation Programme, aligns with and underpins the Strategic Plan.
