CONTRACT PROCEDURE RULES UPDATE

REPORT OF THE DIRECTOR OF ESPO

Purpose of the Report

- 1. The purpose of this report is to seek approval for the revised ESPO Contract Procedure Rules (CPRs), attached at Appendix C to this report.
- Additionally, as the introduction of the Procurement Act 2023 has been delayed, this
 report also asks the Management Committee to consider delegating authority to the
 Finance and Audit Sub-Committee to approve such changes as are required to be
 made to the CPRs before 24 February 2025 in compliance with the Procurement
 Act 2023.

Background

3. ESPO's current CPRs have been in place since 1 October 2021 and need revising at this stage as the introduction of the Procurement Act 2023 has been delayed until 24 February 2025.

Body of the Report

- 4. Rule 8 in the CPRs, which sets out the requirements for Annual Reporting of ESPO's CPR stipulates that the Director of ESPO, in consultation with the Director of Law and Governance, shall at least once in each financial year submit a report to the Management Committee in relation to the operation of these Rules.
- 5. Officers of Leicestershire County Council and ESPO work together on an annual basis to review the Contract Procedure Rules and agree on any draft changes to be proposed for approval.
- 6. The most recent version of the CPRs was approved on 15 September 2021 and has been in place since 1 October 2021. No amendments were proposed to the Contract Procedure Rules in 2022 and 2023.
- 7. Leicestershire County Council has made amendments to its Contract Procedure Rules, which were approved by the County Council's Corporate Governance Committee on 26 January 2024.

Proposed Amendments to ESPO Contract Procedure Rules

- 8. Amendments to ESPO's Contract Procedure Rules have now been proposed to align with the Leicestershire County Council rules referred to at paragraph 6 above, and the amended Rules are highlighted in Appendix A.
- 9. These revisions have been reviewed and are supported by ESPO's Director, Assistant Director: Procurement and Commercial, ESPO's Commercial Solicitor.
- 10. A copy of the proposed Contract Procedure Rules effective from 13 November is set out at Appendix B and C to this Report. These proposed changes were submitted to the Finance and Audit Sub-Committee for consideration at its meeting on 30 October 2024 and were approved for submission to the Management Committee for approval.
- 11. Should the Management Committee approve the draft revised Contract Procedure Rules they will be published on ESPO's intranet and internet sites and communicated to all relevant managers and staff within ESPO, including via newsletters and other appropriate communication channels. They will also be included within ESPO's Constitution which is published on the internet.
- 12. The Public Contracts Regulations 2015 have governed public procurement in the UK to date. However, these regulations will be replaced by the Procurement Act 2023, the introduction of which has been delayed by Government, which will take effect on 24 February 2025 and will introduce new rules for public procurement. This means that procurements commenced on or after 24 February 2025, will be regulated solely by the Procurement Act 2023. Procurements that were commenced before this date will continue to be governed by the Public Contracts Regulations 2015 until all contracts awarded under these regulations have ceased to exist, including any modifications to these contracts.
- 13. Accordingly, the amended Contract Procedure Rules will apply to and govern procurements commenced under previous legislation, The Public Contracts Regulations 2015.
- 14. A new set of Contract Procedure Rules is currently being drafted which will govern procurements commencing on or after 24 February 2025 as required by the Procurement Act 2023. The approval of these Rules, as set out in the Constitution, is the responsibility of the Management Committee. However, due to the delay of the introduction of the Procurement Act 2023, the reporting schedule for ESPO Committees does not enable the Management Committee to approve the new CPRs as its next meeting is scheduled for 19 March 2025, which is after the date when the new terms of the Procurement Act 2023 come into force. As such, the Management Committee is asked to consider delegating authority to the Finance and Audit Sub-Committee to approve such changes as are required to be made to the CPRs before 24 February 2025 in compliance with the Procurement Act 2023. It is expected that this will occur at the next meeting of the Finance and Audit Sub-Committee on 12 February 2025.
- 15. Therefore, moving forward, there will be two sets of Contract Procedure Rules operating alongside each other: one governing those procurements initiated before

24 February 2025, the go-live date of the Procurement Act 2023, and the other covering procurements that commence on and after this date.

Resources Implications

16. There are no resource implications arising from this report.

Recommendation

- 17. It is recommended that the Management Committee:
 - a) approves the proposed amendments to the Contract Procedure Rules, in line with Leicestershire County Council's Rules, detailed at Appendices A, B and C of the report.
 - b) Delegates authority to the Finance and Audit Sub-Committee to approve such changes as are required to be made to the CPRs before 24 February 2025 in compliance with the Procurement Act 2023.

Equality and Human Rights Implications

The Contract Procedure Rules ensure that all suppliers and potential suppliers receive equal treatment when bidding for contracts.
