



Data notes

In order to ensure comparisons are unbiased and insightful the following indicators are used in deriving annual quartile positions as part of the Council's corporate benchmarking approach. These indicators use published statistics from the relevant Government department (e.g. Department for Transport) and Office of National Statistics population data.

Number of passenger journeys on local bus services per head of population.

Reported casualties per million population.

Reported casualties involving road users, walking, cycling and motorcyclists (excluding cars) per million population

Reported Killed or Seriously Injured (KSI) per million population.

Reported KSI walking, cycling & motor cycling per million population.

CO₂ emissions from transport within Local Authority (LA) control per head.
