

## DELEGATED POWERS TO THE DIRECTOR OF ENVIRONMENT AND TRANSPORT

The following Delegated Powers should be read in conjunction with all other relevant parts of the Constitution, in particular –

- The General Scheme of Delegation to Heads of Departments (Part 3)
- The Financial Procedural Rules and Standard Financial Instructions (Part 4F)
- The Contract Procedure Rules (Part 4G)

and the Local Conditions of Service.

Officers should also have regard to any departmental rules and conventions before exercising these powers.

NOTE: -

- *Any exercise of a delegated power shall not involve a key decision.*
- *Any delegation to a Head of Department may be exercised on his or her behalf by any officer authorised by him or her either generally or specifically for the purpose.*

## **Highways**

3. **Abandoned Bridges**  
 Power to accept the transfer of abandoned bridges and/or maintenance responsibility under the legislation in force for the time being. CABINET 14/06/11
4. **Urgent Repairs to Private Streets**  
 Power to exercise County Council functions in respect of urgent repairs to private streets in line with the legislation in force for the time being. CABINET 14/06/11
5. **Highway Works by Third Parties**  
 Power to enter into agreements with third parties for a contribution towards highway works by person deriving special benefit from them. CABINET 14/06/11
6. **Maintenance and Minor Highways Schemes**  
 Power to undertake all highways maintenance and minor highways schemes within the approved estimates including any associated Traffic Regulation Orders, subject to:
  - (a) a limit of £1m (including the cost of land) in any single case;
  - (b) the details of any such minor highways scheme having the support of the local County Councillor(s).

7. **Noise Insulation**  
 Power to exercise the Highway Authority's statutory obligations in relation to noise insulation of properties resulting from highway schemes. CABINET 14/06/11
8. **Extinguishment of Highway Rights**  
 Power, subject to any sensitive or difficult cases being reported to the Cabinet for decision, to approve proposals for orders extinguishing highway rights. CABINET 14/06/11
9. **Highways Dedications**  
 Power to approve dedications of land as public highway which do not involve compensation negotiations or the transfer of any interest. CABINET 14/06/11

10. **Highway Infrastructure Asset Management Plan**
- Power to develop and implement such operational procedures as are considered necessary to ensure the effective delivery of the Highway Infrastructure Asset Management Plan.

11. **Permit Scheme for Street Works and Road Works**
- Power, following consultation with the Cabinet Lead Member, to implement and oversee the on-going management, and to make minor changes to, the Leicestershire County Council Permit Scheme as he considers appropriate.

12. **Making up and adoption of prospectively adoptable / private streets**
- Power in consultation with the Assistant Director of Law and Governance, to exercise the powers and duties of the County Council in relation to the making up and adoption of prospectively adoptable / private streets.

13. **Electricity Contracts for Street Lighting and Illuminated Signs**
- Power, in association with ESPO, to procure through the market energy contracts for street lighting and illuminated signs.

## **Public Rights of Way**

14. **Rights of Way**
- Power:
- (a) to take any action considered appropriate, including legal action with the concurrence of the Assistant Director of Law and Governance, to protect, maintain, improve, keep free from obstructions, waymark and record the public rights of way network, including the power to enter, survey and carry out work on the public right of way pursuant to the relevant legislation in force for the time being. Legal action shall include the serving of notices, issuing of licenses and commencing proceedings;

- (b) after consultation with the Lead Member, to appoint members to the Local Access Forum.

15. **Highways and Public Rights of Way**

Power, after consultation with the Local Member, to exercise the functions of the County Council and to determine any charge under the Highways Act 1980, the Wildlife and Countryside Act 1981 and the Town and Country Planning Act 1990 in relation to highways and public rights of way, provided that in the event that the Local Member requests that a report is submitted to the Development Control and Regulatory Board on the matter the power shall not be exercised by the Director of Environment and Transport.

16. **Motor Vehicle Trials on Public Rights of Way**

Power to determine applications for motor vehicle trials on public rights of way under legislation in force for the time being, subject to prior consultation with the local member for the area concerned and only to grant such licences where traffic could be accommodated within the condition and character of the right of way.

## Traffic and Transport

17. **Minor Transport Schemes**

Power, after consultation with the appropriate Lead Members, to approve details of routine minor transport schemes in the approved transportation Capital Programme, including associated Traffic Regulation Orders, provided the schemes have the support of the local County Councillor(s).

18. **Public Transport Matters**

Power:

- (a) after consultation with the Lead Member and subject to current approved budget provision to enter into arrangements for the introduction, continuation and/or variation of bus service contracts;
- (b) in appropriate circumstances and subject to the concurrence of the Assistant Director of Law and Governance to terminate bus service contracts;

- (c) to take any action necessary to administer the Concessionary Travel Scheme;
- (d) to administer the provision of Home to School and Social Care transport.

19. **Traffic Management Act 2004**

Power to exercise the following functions on the Council's behalf:

- (b) Part III of the New Roads and Street Works Act 1991 (as amended by the Traffic Management Act 2004);

- (d) Part 6 of the Traffic Management Act 2004.

20. **Road Traffic Regulation Act 1984**

Power to exercise the functions of the County Council under the Road Traffic Regulation Act 1984, subject to consultation with the Assistant Director of Law and Governance, (including the power to fix any charge or fee) and including the power, where a scheme has the support of the local member(s) and the appropriate Cabinet Lead Members, to overrule objections.

## Waste

21. **Waste Management Licence Applications, Amendments and Reviews**

Power, after consultation with the Chairman and Spokesmen of the Development Control and Regulatory Board and the local County Councillor(s), to respond to consultations from the Environment Agency on applications for the licensing of waste facilities.

22. **Arrangements for Interim Residual Waste Treatment**

Power, after consultation with the appropriate Lead

Member and the Director of Corporate Resources to make provision for additional waste treatment, if that is considered necessary prior to the delivery of long term residual waste treatment. 14/06/11

23. **Effluent Discharge Consent Applications**

Power, in consultation with the Assistant Director of Law and Governance, to respond to notifications of applications for discharge consents. CABINET

24. **Coventry and Solihull Waste Disposal Company Ltd**

Power to: CABINET

- (a) make any and all decisions in respect of the County Council's shareholding in the Coventry and Solihull Waste Disposal Company Limited;
- (b) attend and participate in the Coventry and Solihull Waste Disposal Company Limited Shareholder Panel on behalf of the County Council or to appoint a nominee to attend and participate on the Director's behalf.

## Licensing

25. **Goods Vehicles Operators Licences**

Power to: CABINET

- (a) exercise all the functions exercisable by the County Council in respect of the maintenance of the County Council's Goods Vehicle Operator's Licence under the legislation in force for the time being;
- (b) enter objections in relation to goods vehicles operator licences on the basis that this should normally be confined to matters affecting the County Council as highway authority.

26. **Licence Charges**

Power to review and increase license charges on an annual basis as part of the general review of charges for County Council services in accordance with legislation in force from time to time. CABINET

## Strategic Planning

### 27. Consultations by Local Planning Authorities

Power to respond on behalf of the highway authority and as the waste disposal authority to any consultations by a local planning authority. CABINET

### 28. Statements of Common Ground

Power to agree the County Council's response to consultations on Statements of Common Ground and to the County Council becoming a signatory to Statements of Common Ground documents with Leicestershire district councils, Leicester City Council and other neighbouring authorities except where these are considered to be of strategic importance to or have significant policy implications for the Authority, in which case the matter will be referred to the Cabinet. ### 29. Strategic Planning Consultations

Power to respond to district councils, neighbouring authorities, statutory undertakers and government departments on behalf of the County Council, except where the proposal: CABINET

- (i) would result in a development that conflicts with a site allocation within an adopted development plan for which the Council is responsible;
- (ii) is considered to be of strategic importance;
- (iii) the local member has requested in writing within 21 days of notification that the proposal should be considered by the Development Control and Regulatory Board and any recommendation considered by the Cabinet.

33. **Amendment of Planning Conditions**

Power, following consultation with the Chairman and Spokespersons of the Development Control and Regulatory Board (the Board), to make non-substantial amendments to conditions imposed by the Board as part of its decision to grant planning permission for an application provided that such changes are not material and do not raise significant new issues requiring referral back to the Board.

## Tree Preservation Orders

34. **Works to Trees**

Power to comment on and/or to determine applications to works on trees protected by a tree preservation order except where the elected local member has indicated in writing within 21 days of notification that the application should be submitted to the Board for determination.

35. **Access to Properties to Inspect Trees Protected by Leicestershire County Council Tree Preservation Orders**

Power to exercise the functions of the County Council under section 214B of the Town and Country Planning Act 1990 to authorise officers to enter land for the purpose of surveying trees in connection with reviewing tree preservation orders and/or exercising any of the functions of the County Council under Part VIII of the Act in relation to trees.

- Power to charge a fee no greater than that permitted in the Regulations covering the issuing of disabled blue badges.
