## **Chairmanships**

The Council's Constitution makes provision for:-

- (a) the Leader of the largest opposition party to be ex officio the Chairman of the Scrutiny Commission;
- (b) the Chairmanship of the Scrutiny Committees to be shared between the political administration group and the opposition group(s).

The remaining appointments of Chairmen and Deputy Chairmen are matters to be determined by the bodies themselves, but the nominations are usually reported to the Council (shown as "Chairman elect").
