1. To inform Members of the progress of permanent Traffic Regulation Orders (TROs) for 2007/08

2. Progress on the programme of TROs is shown in the table below. The actual programme will depend on the complexity of each scheme, speed of responses, level of objections etc.

3. Members will be aware that there is a lengthy formal process to follow before a TRO can be implemented. It may prove that not all of the above schemes will

be implemented during this financial year, or at all, as a result of consultations and public advertisement objections received and other commitments.

4. In addition to the above, there may also be TROs associated with development and other schemes. These will be added to the programme as appropriate.

### **Resource Implications**

5. TROs will be funded from the County Council's Traffic Management Revenue Allocation, apart from those funded by development. The cost of some proposed TROs , such as Borough St Kegworth, will be increased by the need to carryout associated civil engineering works (turning head and provision of bollards)
