Development within Conservation Areas will be required to preserve or enhance the character and/or appearance of the area.</p> <p>Proposals for development on, in, or adjacent to archaeological or other historic sites and buildings will be considered against the need to ensure their preservation and setting.</p> <p>Development will only be acceptable where it would not adversely affect any scheduled ancient monument or other nationally important archaeological site, or its setting or amenity value.</p> <p>Where a known site of county or local significance is to be affected, development may be acceptable which if it would allows its preservation in situ, or, where this is impractical, its investigation and recording.</p> <p>Development will only be acceptable in areas of archaeological potential if proper evaluation of the archaeological implications of the proposed development has been undertaken and taken</p>	<p>In response to representations to the deposit draft plan and in recognition of the fact that development may be affected by the findings of any archaeological evaluation.</p>
