REPORT OF THE CHIEF EXECUTIVE

WORK PROGRAMME

Purpose

- 1. The purpose of this report is to:
 - i) inform the Commission of the deliberations of Scrutiny Committees regarding their work programmes:
 - ii) seek approval to requests to establish two five member scrutiny review panels.

Background

2. The Commission at it meeting on 26th June was advised that the Scrutiny Committees were being asked to consider their respective work programmes having regard to the Constitution, the report agreed by the Council in January, 2001, on the future shape of Scrutiny and subsequent advice from the Scrutiny Reference Group. As a result the various Scrutiny Committees have identified issues that they would wish to look at in the next four to six months. Each Committee has also noted the need to continually review and roll forward its work programme. Details of the work programme for each Committee is set out in the Appendix to this report.

Five Member Panels

3. In considering their work programmes Committees were asked to consider whether any of the issues identified would warrant detailed scrutiny by a five member panel. The Commission on 26th June approved a request from the Highways, Transportation and Waste Management Scrutiny Committee to establish such a panel to consider and comment on the Joint Household Waste Management Strategy. That Panel has commenced work and hopes to be in a position to report by October. The Commission itself agreed to the establishment of a Panel to consider and comment on the emerging Leicestershire Community Strategy and District Community Strategies. That Panel too has commenced work but the nature of its remit will mean that it is not possible, at this stage, to set a timescale within which the work will be completed. An additional five member panels is now being proposed:-

Request from the Education Committee for a Panel to consider the issue of School Attendance

- 4. The Government's social inclusion agenda has led to a whole raft of measures over the past four years specifically designed to raise school attendance levels, reduce truancy and unauthorised absence and tackle the problem of youth crime. The LEA has a key role to play in supporting these measures by ensuring that schools and colleges are given the necessary advice and support to reach and maintain high attendance levels.
- 5. National Targets were set by the Government to reduce unauthorised absence over a three year period from 1999-2000. All LEAs were given targets equating to a reduction of one-third. Leicestershire's targets were as follows:

Primary: 0.1% Secondary: 0.8%

5. Leicestershire's unauthorised absence percentages over the last few vears are:

- 6. In the light of this the Committee is proposing a five member panel with the following terms of reference:-
 - To undertake a review of the current national and local issues relating to school attendance and the action being taken by the LEA to address these issues in Leicestershire.
 - To undertake an analysis of school attendance figures for 2001/2002 to identity key issues, trends, evidence of successful practice and/or areas where further work or different approaches may be needed to tackle poor attendance in Leicestershire schools.
 - To ascertain whether any useful lessons can be learnt from work arising from good practice in Leicestershire and by other LEAs to improve levels of school attendance
- 7. The Group Whips have nominated the following members to serve on this Panel:-

The Constitution sets out the nomination process for Chairmanship of Review Panels. On this occasion the Chairmanship of the Panel is a matter for the Labour Group.
