Public Health Outcomes Framework – Leicestershire

Report 3 – February 2014

1. Purpose of the report

In February 2014, Public Health England (PHE) published a significant update to the public health outcomes framework (PHOF). This is accessible via http://www.phoutcomes.info/.

PHE continue to increase the amount of data that is available at both a county and a district level, and the amount of historical data that is published.

Leicestershire County Council have developed a local dashboard for the PHOF that is available from <u>http://www.lsr-</u><u>online.org/reports/public_health_outcomes_framework_phof</u>

The PHOF includes an extensive list of indicators and allows the performance in Leicestershire to be benchmarked against England. The RAG ratings are based on comparative performance not targets.

2. Key Findings


This release of the PHOF included 148 indicators. The overall findings are summarised below. Overall performance across Leicestershire County is significantly better than the England average for 77 of the indicators presented in the PHOF. Performance is significantly worse for 18 indicators and these indicators need to show improvement.

PHE have included RAG ratings for the first time in this data release. Where possible we have used the same RAG system as PHE. However, for a number of indicators where PHE have not applied a RAG to the data we have assessed this locally. This is indicated in the report.

3. High level outcomes

This is the 1st publication of this set of indicators. Eight indicators have been presented. Leicestershire performance is better than the England average for five of these, it is similar to the England average for one indicators. Significance has not been tested for two indicators. Performance is significantly worse than the England average for no indicators.

In this section, an additional two indicators are presented for England only, these are not considered in this report.

Leicestershire performance is significantly **worse** than the England average for the following indicators:

4. Domain 1: Improving the wider determinants of health

Leicestershire is an area that is more affluent than average and this is reflected in the results that relate to wider determinants of health. 32 of these indicators are presented and show that Leicestershire performance is better than the England average for 13 of these, it is similar to the England average for six indicators. Significance has not been tested for seven indicators. Performance is significantly worse than the England average for six indicators.

Leicestershire performance is significantly **worse** than the England average for the following indicators:

- School Readiness: The percentage of children achieving a good level of development at the end of reception
- School Readiness: The percentage of children with free school meal status achieving a good level of development at the end of reception
- First time entrants to the youth justice system
- Domestic Abuse (* local RAG, data is Leicester, Leicestershire and Rutland)
- Statutory homelessness homelessness acceptances (* local RAG)
- Fuel Poverty

5. Domain 2: health improvement

For health improvement, 33 indicators have been presented and Leicestershire performance is better than the England average for 20 of these, it is similar to the England average for 10 indicators and significance has not been tested for one indicator. Performance is significantly worse than the England average for two indicators.

Leicestershire performance is significantly **worse** than the England average for the following indicators:

- Breastfeeding Breastfeeding prevalence at 6-8 weeks after birth
- Successful completion of drug treatment non-opiate users

6. Domain 3: health protection

For health protection, 25 indicators have been presented and Leicestershire performance is better than the England average for 13 of these, is similar to the England average for two indicators and significance has not been tested for four indicators. Performance is significantly worse than the England average for six indicators.

This section is all local RAG.

Leicestershire performance is significantly *worse* than the England average for the following indicators:

- Chlamydia diagnoses (15-24 year olds) Old NCSP data
- Chlamydia diagnoses (15-24 year olds) CTAD male
- Chlamydia diagnoses (15-24 year olds) CTAD female
- Chlamydia diagnoses (15-24 year olds) CTAD persons
- Population vaccination coverage Flu (aged 65+)
- Population vaccination coverage Flu (at risk individuals)

7. Domain 4: healthcare public health and preventing premature mortality

For healthcare public health and preventing premature mortality, 49 indicators have been presented and Leicestershire performance is better than the England average for 26 of these, is similar to the England average for 20 indicators. Performance is significantly worse than the England average for three indicators.

Leicestershire performance is significantly *worse* than the England average for the following indicators:

- Preventable sight loss age related macular degeneration (AMD) (* local RAG)
- Preventable sight loss sight loss certifications (* local RAG)
- Excess Winter Deaths Index (3 years, all ages)
